The Scenic Elementary Walking and Bicycling Audit was conducted after school on a typical day. Personnel were stationed in the following locations for observation:

- In front of the school for parent pick-up
- Sidewalks and bicycle routes near school property
- Intersection of Scenic Drive and school entrance
- Crosswalk to parent parking lot

Discussion:

There are approximately 215 students that attend Scenic Elementary, 27.5% of whom qualify for the Free and Reduced Lunch Program. Scenic has one regular bus and one Harvard Academy van that wait in the staff parking lot closest to the school. There was one bike rack located uphill from the school grounds that is separated by gravel. There were no bikes parked at the rack but later we learned that there is consistently one bike rider that is accompanied by a parent on most days. There are consistently 10-15 walkers.

Observations/Comments:

Members of the audit team and members of the school community made the following observations and comments regarding the afternoon pick-up and departure: Drop-off/Pick-up Area (front of Scenic Elementary):

- Cars enter school grounds from a hill that could limit visibility. Parents are parking in the staff parking lot next to the school where children are not supervised and cars are not necessarily looking for pedestrians because they are not supposed to be there.
- Cars exiting parent pick-up area are driving too fast.
- Car engines run continuously while they wait to pick up their children.
- Crosswalks and other painted areas need to be evaluated and repainted.
- Signage is small and there is a lack of speed zone signs.

Intersection of school entrance and crosswalk to parent parking lot:

- Crosswalks and other painted areas need to be evaluated and repainted.
- Signage is small and there is a lack of speed zone signs. The stop sign on Scenic Drive is faded.
- There is a lack of sidewalks on school grounds, on Scenic Drive or on Broadway.
- Cars stack up onto W. Scenic Drive. When that happens, some drivers go into the wrong lane of traffic to get into the parent parking area.

Walkers/Bikers:

- There is ample bike parking at the school that is underutilized and there are no bike routes.
- Residents across Broadway are frustrated because there is no crosswalk and no sidewalks along Scenic Drive or Broadway.
- No raised curb to separate pedestrians; school uses cones and painted lines (need repainting).
- Sidewalks are not continuous surrounding the campus.

Best Practices:

- "Children Breathing No Idle Zone" = Engines off sign (e.g. West MS photos)
- Pick-up/Drop-off areas by grade (e.g. Bookcliff MS, Pear Park ES). This may create a safer situation for walkers and bikers.
- Crossing guard gathers kids by school for crossing busy street (e.g. Mesa View ES)
- Crossing guards have standard stop signs, and Class A, Level 2 vests.
- Crossing guards are well trained -- on site training available (e.g. Chipeta report for more on this). Crossing guards need to be paid to take the training.
- Take the time to teach parents how to go through pick-up/drop-off process correctly. (e.g. Bookcliff MS)
- Teach kids to wear helmets.
- Having staff and faculty outside the building at the beginning and the end of day. (e.g. West MS, Rocky Mountain ES)
- Clear and predictable flow of traffic through parking lots. (e.g. Bookcliff MS)
- The Health Assistant and PE teachers are active in promoting healthy transportation to and from school. (e.g. Mesa View ES)
- Hosting a bike rodeo and teaching the bike safety and skills unit in PE.
- Crossing guards shouldn't be teachers or other staff who can't get to their stations in time. (e.g. Tope ES, where the PTO pays crossing guards, and "specials" teachers also have duty)





	GREEN Most favored route. May have a detached sidewalk and/or a bike lane. May be a path that has no vehicle traffic. (A detached sidewalk is separated from the roadway, often by a strip of grass, dirt or rocks.)
	BLUE Has attached sidewalks that are wide enough for 2 people to walk side by side. (An attached sidewalk is right next to the roadway).
	YELLOW Has a place to walk or ride that may be a sidewalk, but could be a path or simply sufficient unpaved space on the side of the road.
	RED Least favored route. Pedestrians and bicyclists must use the vehicle lanes to walk or ride. (No sidewalk and little or no space beyond the white edge line on the side of the road.)





Sex of children for parents that provided information






Parent estimate of distance from child's home to school















1490853	Speeding traffic, as well as no crosswalk or bike path make walking or riding a bicycle an unsafe choice for our family.
1490839	The older my daughter gets the more capable she is of navigating the challenge facing her walk. Including older kids who bully!
1490844	We walk for the exercise as well as to avoid traffic. It would take longer to drive due to traffic flow than to walk to/from.
1490850	11-20 minutes when going to/from glade park. less than 5 minutes when dad picks her up from friends house.
1490888	The children on the south side of Broadway do not have a safe way to cross Broadway. There is a minimal sight distance and traffic goes much too fast to cross.
1490900	We are a transfer family. We are 6-7 miles away.
1490903	I am mostly concerned about my student crossing Broadway.
1490914	We are at scenic on school of choice, we are hoping to move closer to the school soon to start some walking/biking to school.
1490938	We would LOVE to walk from our house in the Ridges to Scenic Elementary, and/or walk to a bus stop. The trouble with walking is the danger and chaos of crossing broadway. The trouble with walking to a bus stop is that no bus serves our neighborhood!
1492180	In the crazy world we live in, unless I was able to escort my daughter via walking or bike - I'd never feel comfortable with her going alone. It's not safe.
1492196	We wish more kiddos and teachers biked in. Our daughter's bike looks so lonely in the rack by itself. Parents leaving the school drive very fast and, sadly, are often distracted. We've seen many texting/on phones.
1492242	I would not allow my elementary school child to walk or bike to school even if improvements were made unless she was accompanied by myself or a trusted adult.
1492269	When we were not school of choice my children would walk to and from school as long as weather permitted. Now we live 10+ miles and just not feasible.
1492276	When we were not school of choice my children would walk to and from school as long as weather permitted. Now we live 10+ miles and just not feasible.
1490842	I don't think he is mature enough to get there on his own, he complains its too far.
1490856	Broadway is too busy!
1490857	We live too far away from my child's school for him to be able to ever walk or ride his bike.

1490863	My child bikes and walks to school but there is no safe way for my child to enter the school and be blocked from traffic (ie a sidewalk along the driveway into school). He has to cut across a private yard to stay clear of traffic.
1490867	We live 1.3 miles from school, down a very busy street. I think my kids would like to ride their bikes but I don't think it's safe for them to ride alone.
1490892	Broadway needs a crosswalk for scenic, Broadway Redlands schools. People drive too fast. Also no sidewalks. *Rural "like" for pedestrians, but people drive like in the city.
1490911	Safety is my biggest concert. If there were crossing guards at every intersection on the way AND sidewalks the whole way, I would feel comfortable, maybe.
1490913	If there was a crosswalk on broadway with a crossing guard, we would bike to school as much as possible.
1490927	Last year at Taylor Elementary we rode our bikes to school almost everyday - we live 2 blocks away and didn't have to cross a busy road like broadway.
1492260	We live on W Scenic Drive. There are no sidewalks in the direction my child walks. Cars do not stop for the kids trying to cross and the cars speed. Lots of kids hang a left out of the parking lot and head North on W Scenic Drive Going around the corner to East scenic Drive
1490865	We live to far for her to walk to school.
1490922	Cars drive way too fast around the corners of West scenic drive and East scenic drive.
1490932	Ridges Blvd and W scenic drive both need stop lights. If traffic is busy, it is difficult and dangerous to turn left. Broadway is simply too busy and dangerous for young children to be biking and walking to school.
1490941	We are a 1 vehicle family, without school bus transportation my kids would not make it to school when my husband works. The highway traffic and lack of sidewalks is not safe.
1492220	We are school-of-choice and live 20 minutes away so this survey really doesn't pertain to us.
1492222	Another main concern is Mr.s Green's dogs.
1492232	We are school of choice - too far to walk. However, if we lived close I would be concerned about lack of sidewalks near Scenic.
1490907	Buses should still be offered even though you are within 2 miles of school. Every child should get the option to be bused.
1490940	We did school of cohice so we are pretty far away.
1490908	It is very difficult for us to walk/bike to school even as a family because we have 5 children, two under school age.
1490872	School buses NEED to be provided for children living a mile or more away or for unsafely exposed to traffic on Broadway.

1490910	Problems in 10 are not one or the other, rather they are all of the checked boxes would need to be improved before we let the kids ride their bikes. They would bike/cross a major highway so we would never allow them to bike.
1490912	No answer for 12-14 as N/A. We live across town which is why my child doesn't walk.
